

**ALAIEDON TOWNSHIP BOARD OF TRUSTEES MINUTES**  
**Monday, March 25, 2013**

The regular Alaiedon Township Board meeting held Monday, March 25, 2013 was called to order at 8:00 p.m. by Supervisor Steven Lott. Members present: Supervisor Steven Lott, Clerk David Leonard, Trustee Bruce Oesterle, Trustee Beth Smith, and Deputy Clerk Virginia Coffman. Treasurer Scott Everett was absent.

Public in attendance were: Todd McCastle and Randy Maiville.

Motion by Leonard, supported by Oesterle, to approve the minutes of the March 11, 2013 meeting as printed. Motion carried.

Motion by Leonard, supported by Smith, to approve the agenda as printed. Motion carried.

Todd McCastle of Michigan Carpenter's Apprenticeship located at 681 Dart Rd attended the meeting to request the procedure to be able to attach the present two separate pole structures together. Currently on the property there is a total of 10,328 sq ft in accessory structures on a 3.28 acre parcel. On this size parcel the present zoning ordinance only allows 2,650 sq ft of accessory building structures. The property has a special use permit issued in 1988 for operating a Carpenter Apprentice Training School. The Clerk will check with the Township Attorney about the possibility for this construction proposal.

Randy Maiville Ingham County Board Commissioner attended the township board meeting to see if the Board had any questions or concerns for him.

Motion by Oesterle, supported by Smith, to hire Wolverine Engineering & Surveyors, Inc. to perform the surveying services for the continuing Leek Cemetery expansion, driveway staking at the cost of \$3,250.00 and the monument staking of 267 new lots for cost of \$4,550.00. Motion carried.

The Board reviewed the Ingham County Department of Transportation and Roads 2013 road recommendations. Supervisor Lott had been in contact with James Benjamin and they will be looking at Willoughby Road together and they are going to use a rubber seal on the University Commerce Park. Every/Button Roads can wait. Supervisor Lott will contact Mr. Benjamin on a quote for just Willoughby Road.

The Board received an e-mail with concerns about horse rider's safety on Sandhill Road between Hagadorn and Okemos Road. They are requesting signs be placed along the area. Supervisor Lott will talk to Mr. Benjamin about this safety concern also.

Motion by Leonard, supported by Smith, to pay the following invoices: General Fund check #11463 through #11479 in the amount of \$138,386.53. Tax Account check #5734 through #5740 in the amount of \$1,444.97. Trust and Agency Account check #1730 through #1731 in the amount of \$4,380.34. Motion carried.

Motion by Smith, supported by Oesterle, to adjourn. Motion carried at 8:32 p.m.
